Remember all outdoor burning ends on May 1st and is completely banned until October 1st to comply with area Air Quality regulations.

Tuesdays and Thursdays: February 2 through April 13 from 9:00am to noon. First come, first serve basis. Trained and certified volunteers will prepare your federal and state income tax return. Bring a copy of all 2016 forms indicating federal income tax paid, including W-2 from each employer, 1099 and 1095. If you were paid Social Security benefits, bring your SSA-1099. Bring your 1099R if you received a pension or annuity. If applicable, unemployment compensation statements, child care provider information (name, employer ID, and SSN), mortgage interest paid, charitable contributions, and Social Security numbers for all dependents. Bring 2015 return to process 2016 return. AARP Tax Aide is administered by the AARP Foundation.
